We ask our customers using this method of payment be patient as this could take seven to ten business days. It is preferred customers pay by credit card or money order. Any check that is returned NSF will be charged a \$25.00 processing fee.

Shipping: Tarantula Performance Racing will ship via UPS Domestic Ground Service. Tarantula Performance Racing is not liable for any damages during shipping. All goods are carefully packed and are in good condition when shipped. Lost, damaged or stolen claims must be made with Tarantula Performance Racing. Tarantula Performance Racing assumes no responsibility beyond delivery to the carrier and is not responsible for loss, damage or delay occurring thereafter.

Returns: Return Authorization (RA) numbers are required to send back any and all merchandise to Tarantula Performance Racing.
